

## SOLARFLARE COMMUNICATIONS, INC. TERMS OF USE

**PLEASE READ THESE TERMS OF USE (AS AMENDED AND MODIFIED FROM TIME TO TIME, THESE “TERMS OF USE”) CAREFULLY BEFORE USING THIS WEBSITE LOCATED AT <http://www.solarflare.com> (THE “SITE”) OR ANY PRODUCTS AND/OR SERVICES DESCRIBED OR PROVIDED THROUGH THE SITE BY SOLARFLARE COMMUNICATIONS, INC. (“SOLARFLARE”, “US”, “WE”). IT IS IMPORTANT THAT YOU (AS DEFINED BELOW) READ CAREFULLY AND UNDERSTAND THESE TERMS OF USE. SOLARFLARE STRONGLY SUGGESTS THAT YOU PRINT A COPY OF THESE TERMS OF USE (WHICH ARE ALSO FOUND AT THE TERMS OF USE LINK AT THE BOTTOM OF EACH PAGE OF THE SITE) AND KEEP A COPY THEREOF FOR YOUR RECORDS.**

Your continued use of the Site after such notice shall be deemed acceptance of such changes. **1. Introduction.** Through the Site, Solarflare provides data and information about itself and in connection with its business, products and services, including, without limitation, standards-compliant 10GbE server adapters and network silicon, and next level of high-performance 10 Gigabit Ethernet (10GbE). The data, information and materials provided through the Site, including any data, text, documentation, graphics, images, logos, icons and links (collectively, the “**Materials**”), are intended to educate and inform you about Solarflare and its products and services, as well as facilitate you in your use of such products and services. The Materials remain the property of Solarflare or its licensors or suppliers. You shall not alter or modify any part of the Site other than as may be reasonably necessary to use the Site for its intended purpose; and you shall otherwise comply with the terms and conditions of these Terms of Use. Solarflare cannot guarantee that technical difficulties shall not occur during the download of the Materials or that the Materials will download successfully. You may not engage in the unauthorized use, copying, or distribution of any of the Materials. If you download or print a copy of the Materials as expressly permitted in these Terms of Use, you must retain all copyright and other proprietary notices contained therein. You may not reproduce, display, publicly perform, or distribute the Materials in any way.

**2. Accounts.** Some areas of the Site may require you to be or become a registered member of the Site. When and if you register to become a member, you shall (a) provide accurate, current and complete information about yourself as prompted by Solarflare's registration form and (b) maintain and update your information to keep it accurate, current and complete. ### **3. Code of Conduct.**

Without limiting the generality of anything set forth in these Terms of Use, you shall not (collectively, the "**Codes of Conduct**"):

- Restrict or inhibit any other visitor or member from using the Site, including, without limitation, by means of "hacking" or defacing any portion of the Site;
- Disguise the origin of information transmitted through the Site;
- Use the Site, the products and services described on or offered through the Site, or the Materials for any unlawful purpose in any unlawful manner;

**4. **5.
